An Ordinance Concerning Granting Of Licenses for the Operation of Billiard Tables, Pool Tables, Bagatelle or Pigeon Hole Tables or Bowling Alleys, and Amending Section One of Ordinance Number Fourteen of the Town of Hillrose, State of Colorado.

Be it ordained by the Board of Trustees of the Town of Hillrose, State of Colorado.

Section 1. That Section One of Ordinance Fourteen of the Town of Hillrose, passed and adopted the 4th day of August, A. D. 1919, be and the same is hereby amended as follows:

That it shall be unlawful for any person or persons to keep or maintain, or allow to be kept or maintained or used in any Billiard Hall, or other public place or public building within the incorporated looks of the Town of Hillrose for gain, or for the amusement of the patrons thereof without gain, compensation or profits to the owner or person controlling or allowing the same to be used; any Billiare Table, Pool Table, Bagatelle or Pigeon Hole Table, or Bowling Artey, without first having obtained a license from the board of Trustees of said Town, provided, however, that only one such license may be issued by the Board of Trustees for the first One Thousand (1,000) population of said town, and not more than one additional such license for each five hundred (500) or fraction thereof of papulation in excess thereof.

Section 2. All ordinances and parts of ordinances in conflict herewith are hereby expressly repealed.

An Ordinance Concerning Granting Of Licenses for the Operation of Billiard Tables, Pool Tables, Bagatelle or Pigeon Hole Tables or Bowling Alleys, and Amending Section One of Ordinance Number Fourteen of the Town of Hillrose, State of Colorado.

Be it ordained by the Board of Trustees of the Town of Hillrose, State of Colorado.

Section 1. That Section One of Ordinance Fourteen of the Town of Hillrose, passed and adopted the 4th day of August, A. D. 1919, be and the same is hereby amended as follows:

That it shall be unlawful for any person or persons to keep or maintain, or allow to be kept or maintained or used in any Billiard Hall, or other public place or public building within the incorporated ladits of the Town of Hillrose for gain, or for the amusement of the patrons thereof without gain, compensation or profits to the owner or person controlling or allowing the same to be used; any Billiare Table, Pool Table, Bagatelle or Pigeon Hole Table, or Bowling Artey, without first having obtained a license from the board of Trustees of said Town, provided, however, that only one such license may be issued by the Board of Trustees for the first the Thousand (1,000) population of said town, and not more than one additional such license for each five hundred (500) or fraction thereof of population in excess thereof.

Section 2. All ordinances and parts of ordinances in conflict herewith are hereby expressly repealed.
